Appellate District Courts: *(Your local ballot will only have 1 of these 3 districts judges.)*

Eastern – Mary Kathryn Hoff – “NO”.

Southern – Robert S. Barney – “NO”, Don E. Burrell – “YES”.

Western – Alok Ahula – “NO”, Victor C. Howard – “NO”, Karen King Mitchell – “NO”, Mark D. Pfeiffer – “NO”, James Edward Welsh – “YES”.

There are an additional 71 state judges, as well as many local municipal judges, that will be on ballots across the state, only a few may be in your ballot booth.
